JUDGMENT

THIS MATTER came before me for trial with a jury in the City of Barrie on May 18, 19, 20, 24, 25, 26, 27, 30, and 31, June 1, 2, and 3, 2016, put over to January 20, 2017 for a determination on the issues of collateral benefits and costs.

UPON hearing the evidence and the submissions of counsel for the Plaintiffs and for the Defendants Geoffrey Michael Kremer and Matthew Rushton, this action having been dismissed against the Defendant, Robert Rushton, by Order dated March 18, 2015:

1. **THIS COURT ORDERS AND ADJUDGES** that the Plaintiff, Meaghan Dunk, does recover damages in the amount of \$975,060.00 from the Defendants, Geoffrey Michael Kremer and Matthew Rushton.
2. **THIS COURT ORDERS AND ADJUDGES** that the Plaintiff, Meaghan Dunk, does recover prejudgment interest from the Defendants, Geoffrey Michael Kremer and Matthew Rushton, in the amount of \$64,541.00.

3. **THIS COURT ORDERS AND ADJUDGES** that no amount in respect of collateral benefits shall be deducted from the damages recovered by the Plaintiff, Meaghan Dunk from the Defendants, Geoffrey Michael Kremer and Matthew Rushton.

4. **THIS COURT ORDERS AND ADJUDGES** that the Plaintiff, Meaghan Dunk, shall recover costs from the Defendants, Geoffrey Michael Kremer and Matthew Rushton, in the amount of \$352,482.13 for fees and in the amount of \$132,040.00 for disbursements; both inclusive of HST.

5. **THIS COURT ORDERS AND ADJUDGES** that the Plaintiff, Shelby Dunk, shall recover disbursements from the Defendants, Geoffrey Michael Kremer and Matthew Rushton, in the amount of \$77,498.00 inclusive of HST.
