PARTIAL JUDGMENT


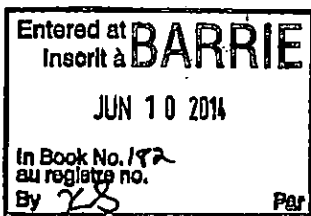
THIS ACTION was heard between May 20 and June 5, 2014 with a jury, at the
Courthouse, 75 Mulcaster Street, Barrie, Ontario, in the presence of lawyers for all

parties, no one appearing for the defendants, Przemyslaw Marzec and Agnieszka Marzec, who were both properly served and then noted in default on May 15, 2012.

ON READING THE PLEADINGS AND HEARING THE EVIDENCE and the submissions of the lawyers for the parties, and upon receiving the verdict of the jury,

1. **THIS COURT ORDERS AND ADJUDGES** that the plaintiff, Peter Yetman, be paid non-pecuniary general damages by the defendants in the sum of ONE HUNDRED AND THREE THOUSAND AND TWO HUNDRED DOLLARS (\$103,200.00);
2. **THIS COURT FURTHER ORDERS AND ADJUDGES** that the plaintiff, Peter Yetman, be paid past loss of earnings by the defendants in the sum of ONE HUNDRED AND FORTY FIVE THOUSAND AND EIGHT HUNDRED DOLLARS (\$145,800.00);
3. **THIS COURT FURTHER ORDERS AND ADJUDGES** that the plaintiff, Peter Yetman, be paid future loss of earnings by the defendants in the sum of SEVEN HUNDRED AND FORTY THOUSAND DOLLARS (\$740,000.00);
4. **THIS COURT FURTHER ORDERS AND ADJUDGES** that the plaintiff, Peter Yetman, be paid loss of future housekeeping capacity and loss of future handyman capacity by the defendants in the sum of FORTY TWO THOUSAND DOLLARS (\$42,000.00);

5. **THIS COURT FURTHER ORDERS AND ADJUDGES** that the plaintiff, Peter Yetman, shall be paid pre-judgment interest on general damages and past loss of earnings by the defendants, in an amount to be assessed at a later date.
6. **THIS COURT FURTHER ORDERS AND ADJUDGES** that the plaintiff, Peter Yetman, shall be paid his costs and disbursements, by the defendants, in an amount to be assessed at a later date.
7. **THIS COURT FURTHER ORDERS AND ADJUDGES** that the money owing under this Judgment, including the pre-judgment interest, costs and disbursements to be later assessed, shall accrue post-judgment interest from the date of this Judgment at the rate of 3% annually.
